Dear Applicant:

Please read through the application thoroughly and review the copy of the booklet "Laws Relating to Permits to Carry Concealed Handguns". This is located on the Maine.gov website, link listed below.

ALL APPLICANTS: Please complete and return this entire package and include the following items:

- *Application for a Permit to Carry Concealed Handguns, pp. 1-6
- * Authority and Authorization to Release Information forms must **BOTH** be filled out completely by the applicant whether applying for the first time or renewing. NOTE: Where a witness signature is required, the date of the Witness signature must match the date of the Applicant Signature.

NEW APPLICANTS: Fee of \$35.00 – Include the following with your application:

- *Proof that you are a full-time resident of the Town.
- *A copy of your Birth Certificate or INS document.
- *A copy of a certificate issued within the past 5 years, showing completion of a Handgun Safety Course **OR** DD214 - If you are or were a member of the Armed Forces of the United States of America, a copy of your DD214 serves as proof of knowledge of handgun safety. You must have served long enough to complete basic firearms training. You also may NOT have a dishonorable discharge from the service.

Notice: If your permit is expired over 6 months, you are considered a **New** applicant and must pay the \$35.00 fee. You are required to submit your supporting documents (e.g. Birth Certificate, Hand Gun Safety Certificate, DD214) **OR** a copy of your most recently expired Concealed Weapon Permit.

RENEWAL APPLICANTS: Fee of \$20.00 - Submit a copy of your most recent permit with the application.

Attention: You are a Renewal Applicant If your permit is NOT more than 6 months expired and you have NOT changed your address more than 30 days prior without notifying the Issuing Authority. If you moved over 30 days prior without notifying us, you are a **NEW** applicant and your current permit is also invalid.

DUPLICATE, CHANGE OF ADDRESS OR NAME CHANGE APPLICANTS: Fee \$2.00 - Include:

- *Completed application
- *Proof of address and /or name change
- *A copy of your current permit

NOTE: If you hold a current Windham permit **and** your move is within the town of Windham, you may submit pages 1, 5 and 6 of the Windham application form only. (abbreviated version)

You will be contacted upon completion of background check process to have your photo taken, as we now issue photo ID permits. Or, you may call 207-892-1919 to make arrangements for your photo any time after your application is submitted to the Town Clerk's office.
